These instruments are provided as security deposits pursuant to our agreement, and are intended to safeguard against any breach or default thereof and will be forfeited if the applicant breach the agreement..

I hereby comprehend and consent to the condition that the pay order and cheque referenced herein shall be returned to me exclusively upon the participant's successful return to Pakistan and after the applicant's return, it is imperative that he refrains from reusing or flying again on the specified visa without obtaining prior permission from StudenTravel. In the event of the participant prolonging their stay with the intent to unlawfully remain, initiating proceedings for asylum, or absconding to any other European jurisdiction anytime without permission, I acknowledge the imposition of a penalty in the amount of Rs. 2,000,000/- PKR, for which I am liable to remit payment to StudenTravel.

Furthermore, I am cognizant that the failure to fulfill the aforementioned condition may result in both civil actions (such as suits for recovery, damages, compensation, and defamation) and criminal charges (under sections 420 PPC, 406 PPC, 34 PPC 489F PPC, and relevant provisions of Pakistan panel code 1860 and relevant laws) being instituted against me, in accordance with the domestic laws of Pakistan and applicable international legal norms.

It is imperative to note that if I or applicant issue cheques or pay orders, it is crucial to acknowledge that once issued, that cannot be stopped unilaterally by us. In the event of any attempt to halt such instruments by us, it is imperative to recognize that legal proceedings will be initiated in the competent court of law, in accordance with relevant laws and regulations.

I and below mentioned applicant, along with criminal and civil liability, are also liable to indemnify the company in the event of a breach of any condition specified in the contract.
