

DECLARATION BY THE PARTICIPANT

I, _____, residing permanently at _____, with contact number _____, Passport No. _____, and Date of Birth _____, hereby solemnly affirm and declare that there are no pending legal cases, police First Information Reports (FIR), or threats against me within the jurisdiction of Pakistan. This declaration is made in accordance with the laws governing this contract and shall be admissible as evidence in any court of law.

In substantiation of this assertion, I herewith submit the following documents:

1) Police Clearance Certificate issued by NADRA.

Furthermore, I affirm that any application for asylum in Europe made under false pretenses would constitute fraudulent misrepresentation. My intention is solely to partake in an educational excursion facilitated by my university. Upon conclusion of said tour, I shall promptly return to Pakistan.

I hereby declare and agree as follows:

1. In the event of any suspicious behavior on my part, StudenTravel is granted full authority to commence the process of my deportation to Pakistan.
2. StudenTravel is authorized to retain possession of my passport for the entire duration of the tour in Europe.
3. Legal action shall be pursued against both myself and my guarantor should I travel to any country other than those initially planned.
4. I and my guarantor, along with criminal and civil liability, are also liable to indemnify the company in the event of a breach of any condition specified in the contract.

5. StudenTravel unequivocally disclaims any responsibility or liability arising from actions or decisions undertaken by any state or federal immigration agency. I acknowledge and agree that StudenTravel shall bear no financial responsibility for any consequences, including but not limited to delays, detentions, or denial of entry, resulting from events or actions compelled by federal immigration agencies at airports or border crossings. StudenTravel is in no way responsible by any action conducted by any state's immigration agency. There will be no financial liability on organizers in case of any event forced by any federal immigration agency on airports and borders.

6. StudenTravel is obliged to report any unauthorized attempt by me to reside in Europe without prior consent to the relevant authorities, namely the foreign affairs. Furthermore, I am cognizant that the failure to fulfill the aforementioned condition may result in both civil actions (such as suits for recovery, damages, compensation, and defamation) and criminal charges (under sections 420 PPC, 406 PPC, 34 PPC 489F PPC, and relevant provisions OF PAKISTAN PANEL CODE 1860 AND RELEVANT LAWS) being instituted against me, in accordance with the domestic laws of Pakistan and applicable international legal norms.

It is imperative to note that if I or guarantor issue cheques or pay orders, it is crucial to acknowledge that once issued, that cannot be stopped unilaterally by us. In the event of any attempt to halt such instruments by us, it is imperative to recognize that legal proceedings will be initiated in the competent court of law, in accordance with relevant laws and regulations.

That, Upon the return, it is imperative that I refrain from reusing or flying again on the specified visa without obtaining prior permission from StudenTravel.

7. It is hereby acknowledged that my guarantor bears full responsibility for my actions while in Europe.
